Arrival at the site: 8:00 am. Check in between 8am and 8:30 am.

In light of CoVid precautions, there will be no indoor crating; please work from your vehicles. Please wear a mask and maintain social distancing. There will be a limited number of teams in the building at a time. Details will be explained in the written briefing to be sent the week of the event.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs, will be run at the end of their class/trial, and must wear “panties” while competing. Entry fees for bitches that come into season will be refunded until the time of the trial if you wish to withdraw. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge’s briefing.

Ribbons will be awarded to all qualifying teams – Rosettes will be awarded for all placements and new titles.
